I, \_\_\_\_\_, authorize the auctioneer or a proxy bidder to represent me during the live auction to take place on June 1, 2017 (the "Auction") at A *Celebration of Heroes, Heart and Hope Gala* at the Hilton Midtown New York benefiting the Challenged Athletes, Inc. a California non-profit corporation dba the Challenged Athletes Foundation ("CAF") for a triathlon race slot in the 2017 IRONMAN® World Championship on October 14, 2017, organized and conducted by World Triathlon Corporation ("WTC"), held in Kailua-Kona, Hawaii in October (the "Kona Slot"). I understand that the Kona Slot is transferable, and that either I or another person I designate (the "Designee") may use the Kona Slot. I understand that in order to use the Kona Slot, I or the Designee must have completed an IRONMAN® or IRONMAN® 70.3® branded triathlon between October 10, 2016 and August 15, 2017 and that I or the Designee must complete, sign and submit to WTC a race application and an Event Registration Agreement and Release and Waiver of Liability by August 1, 2017 in order to use the Kona Slot for that year. I understand that the Kona Slot is valid for 2017 and that the Kona Slot will not be valid at a future date for any reason.

My bid will be executed for the lowest possible price as is permitted by other bids in an effort to purchase the Kona Slot at a price below my maximum bid. I authorize my proxy bidder, however, to increase my bid in \$1,000 increments up to my maximum bid, which I have indicated above. Should my bid be the highest bid, and should I be successful in purchasing the Kona Slot, I authorize the CAF to charge my credit card, for which I have provided information, for the full amount of my winning bid.

I understand that I am submitting my bid for the 2017 Kona Slot to the CAF at my own risk, and that neither the CAF, WTC, nor their subsidiaries, affiliates, related entities, partners, agents, officers, directors, employees, members, shareholders, attorneys, heirs, successors, and assigns, nor their proxy bidders, (collectively the "Released Parties") shall be liable for the failure to place my bid, whether through negligence or otherwise.

I hereby waive, release, and forever discharge the Released Parties from any and all claims, obligations, liabilities, causes of action, suits, debts, liens, damages, judgments, losses, demands, costs and expenses (including, without limitation, attorneys' fees) of any kind which may directly or indirectly arise out of, result from, or relate to the Auction.

I agree to indemnify and hold harmless the Released Parties from any and all claims arising out of or resulting from, directly or indirectly, (a) any of my or the Designee's acts or omissions, and/or (b) my or the Designee's breach or failure to comply with any provision contained herein. I understand that failure to comply with either of these conditions will mean that the Kona Slot may no longer be available to myself or the Designee. Should this occur, I understand that any payment made to CAF is in no way refundable. I am 18 years or older and can form legally binding contracts under applicable law.
